

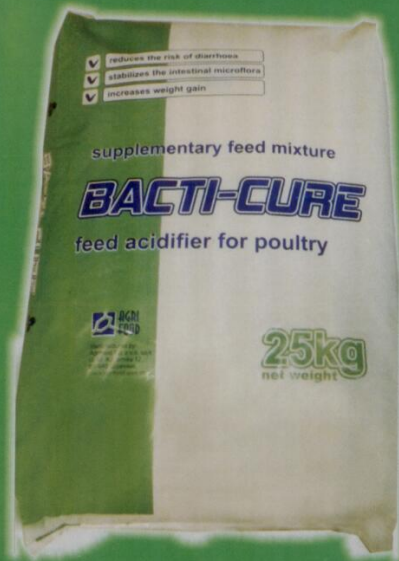

On an average, 5.5% of all fresh poultry meat samples within the European Union was found to be contaminated. Also, one out of every ten fattening pigs in Europe carries salmonella, according to a random sampling that EFSA carried out recently. The beginning of 2009 marked the European Union's ban on the sale of fresh eggs from flocks infected with either Salmonella enteritidis or Salmonella typhimurium. A recent study in Europe demonstrated that the most important risk factors for salmonella contamination are dust, surfaces and feces, stressing the importance of proper farm hygiene. The same study showed that day-old chicks reached farms highly contaminated, emphasizing the need for bacterial control especially in breeder feed production.
